### **Paytm pegs IPO at \$20 bn valuation, CEO says 'life to become QSQT**

Paytm IPO will be at \$19.5 billion to \$20 billion valuation, the company officially revealed for the first time on Thursday. Paytm was valued at \$16 billion when it raised funds two years ago. The IPO was priced at a lower valuation so that more people can participate, the company said. In a media conference call, Founder and CEO Vijay Shekhar Sharma said, "Our life is going to become QSQT now or quarter se quarter tak (from one quarter to next)." He added that there is no interesting acquisition target on the horizon and the company is more focused on building itself as compared to buying. "But never say never," he added.
