Analysts wary of Zomato IPO's big valuation

Ahead of Zomato Ltd's initial public offering (IPO) opening for subscription on Wednesday, analysts were optimistic about listing gains, but were cautious about the firm's long-term risks. The expensive valuation demanded at a time the food delivery service company is still making losses and upcoming competition with Amazon's entry into the segment are making analysts wary.

Flipkart's valuation crosses \$37.6 bn after raising \$3.6 bn in funding

E-commerce giant Flipkart Group has carved a niche for itself in the global league by raising \$3.6 billion, including from SoftBank, which had exited the firm, valuing the company at \$37.6 billion, which is more than a 50 per cent rise in a year. Last July Walmart led a \$1.2-billion round in Flipkart, valuing the e-commerce firm at \$24.9 billion.
